ABSTRACT

The Swish White Paper will present and explain the features and innovations of our system . Also, we will review the details of our first coin offer (ICO) and present our ideas and ambitions of the future platform and Swish ecosystem. The Swish system is designed to simplify the process of searching scientific articles and improving the cooperation between innovative companies and people making scientific discoveries. He will solve many issues related to the process of transferring scientific material, including, but not limited to:

- uncontrolled influence and abuse of powers of the central authority
- fake or undeserved feedback about work
- refusal to pay for the agreed amount of money for the project

MARKET AND INDUSTRY

The whole world around us consists of technologies. Any device that makes our life easier, such a mobile phone, tablet, computer, washing machine appeared thanks to the development of people engaged in science. Large companies in addition to hiring employees in the staff actively use the scientists working independently.

Currently, freelancers account for about 35% of the US workforce. During the past year, the entire freelance workforce received an aggregate income of about 1 trillion. US dollars, which represents a significant share in the US economy. Giants of the IT industry are interested in new developments and from year to year they will acquire more and more scientific materials that can make a breakthrough in science.



THE TOKEN


A holder of the Swish benefits from the Swish system in several ways.

PREMIUM ACCOUNT

Access to premium accounts is restricted to Tokenholders. Only Tokenholders, who hold a certain amount of SwishTokens, for a period longer than 1 month get access to premium features of the platform. This way we incentivize people, who are interested in the long-term success of Swish. People, who are holding Swish Tokens purely for speculative reasons and short periods of time, will not be able to use premium features. With the success of the Swish platform the demand for Tokens will increase, on the other hand the supply for Swish Tokens will decrease, because premium users will not sell their Tokens, because they would lose access to the premium features.

PRIME ACCOUNT FEATURES

Premium-account includes such functions as:

- Access to detailed profile statistics. Know who published this scientific material, statistics of its publications and customer reviews.
- Your scientific publications will be ranked by our search engine.
- Your application for the search for scientific materials will be evaluated higher than for candidates who do not have prizes.
- Get quick access to new features.
- The minimum required amount (5000 SWI) will never be reduced.

RATINGS AND REVIEWS

The authors of the developments and clients can provide feedback to each other and share the experience of perfect work on projects. Development authors or clients can evaluate each other on a scale of 1 to 10. They can also add a written review, which is optional. Each scientific author has a summary score, which is always displayed along with the user's name. Scientific authors also have a separate rating for each skill (for example, Neurocomputers, Programming, Medicine ...), which allows the potential client to determine in more detail the level of knowledge and qualifications of the author, which makes the process of finding a suitable scientist much easier.

The authors also have a separate rating of skills in each field of activity individually, because the overall rating will not tell about the author's abilities in certain areas of science. After successful work, the author receives 1 additional score in each skill that is required for this work. The author's rating rises in accordance with the number of scientific materials that scientific companies have acquired.

USER PROFILE

User profile is a set of settings and information associated with a particular author. The user profile is the main page after clicking on the user name on any Swish platform site. It contains all the important information about a specific scientific author, such as:

- Username: The user name that the user chose when registering with the system. It is always displayed when the user is displayed on the system.
- Brief description: Brief description of the author (<150 words).
- Description: Full description of the author and his articles.
- Name: The user name is displayed only in the profile.
- Last name: The user's name is displayed only in the profile.
- Skills: the fields of science in which the author works, including the rating for each sphere.
- Skill rating: The author receives an evaluation after his scientific articles have been published or used to create a new technology.

USER PROFILE

- Education: education is the schools, courses or degrees that the author has filled out.
- Experience: experience precedes scientific works or projects, on which the author worked earlier.
- Lost disputes: the total amount of lost disputes.
- Won disputes: the total number of disputes won.
- General disputes: the total amount of disputes in which the user was included.
- Image profile: Image of the size of the user's square size.
- Rating: the general rating of the author.
- Location: the country where the author lives now.
- Token holder: determines whether the user is a token holder or not.


